**Call to Order.** The Faculty Assembly met at 10:00 a.m. on Saturday, November 7, 2009, in the State Regents' Conference Room. Faculty Advisory Council (FAC) Chairman Nancy Osborn (USAO) presided. **Introductions.** Participants introduced themselves by providing name, institution and discipline.

**Oklahoma Higher Education Legislative Update.** Chairman Osborn introduced Chancellor Glen D. Johnson who presented the legislative budget request which was developed between July and late October. Campus visits to discuss the budget will be held during the winter. Legislative issues discussed included use of technology and online courses, textbook costs, transfer activity, student success, tuition and fee increases, and pipeline of students. The PowerPoint slides will be made available.

**Status of Workplan.** Nancy Osborn distributed the 2009 Annual Report, provided an overview of the FAC charge, and reviewed the 2009 workplan.

**Issues.** Identification of top issues confronting Oklahoma college and university faculty.

**Faculty Opinion Survey results.** The following issues were most frequently cited: student preparation for college, quality of online courses, cost of textbooks, concealed weapons on campuses, voice at State Capitol, faculty salaries, and health benefits.

**Comments from representatives.** Discussion among participants identified additional issues: adjunct faculty pay, veteran services, and coordination with common education.

**FAC Member Election.** Chairman Osborn provided an overview of procedure for nominations and breakout into tier groups for deliberations. The groups met separately to nominate representatives to the FAC as follows:
