Strategies for Institutional Engagement Conference

Eighty-seven of Oklahoma's higher education Vice Presidents, Deans, Service-Learning Coordinators, Community Service Directors and faculty attended the Oklahoma Campus Compact conference on February 4, 2008 in Oklahoma City to hear presentations from and engage in questions and answers with the following two national leaders in Institutional Engagement:

- Dr. Robert G. Bringle, Chancellor's Professor of Psychology and Philanthropic Studies, and Director for the Center for Service and Learning, School of Science University Graduate School, Indiana University-Purdue University Indianapolis; and
- Dr. Amy Driscoll, Consulting Scholar, The Carnegie Foundation for the Advancement of Teaching.

Dr. Bringle addressed issues in strengthening institutional support for service-learning and civic engagement, and spoke directly to documentation in compliance with accreditation for the Higher Learning Commission's Criterion Five on Engagement and Service. He highlighted an American Association of Colleges and Universities Survey of Employers on the "Best Methods for Ensuring that Graduates have Knowledge/Skills" which showed that 83% of the employers surveyed thought that Internship/Community-based Projects Where Students Apply College Learning in Real-World Settings was the most effective. Other topics covered by Dr. Bringle included Promotion and Tenure,

Participatory Research, Institutional Portfolios, and Resources.

Dr. Bringle's presentation was followed by a panel of Dr. Terry Britton, President, Rose State College; Dr. Kent Johnson, Director for the Program for Instructional Innovation, University of Oklahoma; and Dr. Corey Moore, Professor and Chair of Rehabilitation, Counseling and Disability Studies, Langston University, in discussion of Oklahoma aspects.

Dr. Driscoll spoke to Carnegie's 2006 Community Engagement Classification, giving its intentions, and detailing the application and review process. After covering the different categories and providing examples, she shared observations on strengths, areas needing improvement, the benefits of the CE Classification, and tips from recently classified institutions.

Over lunch the conferees heard a presentation on the Convergence in Civic Engagement and Service Learning from Dr. Kathryn Gage, Vice President for Student Affairs, and Mr. Josh Krawczyk, Director of Volunteer and Service Learning, and Assistant to the Vice President for Student Affairs, from the University of Central Oklahoma. The presentation addressed collaboration in Student and Academic Affairs.

Campus Compact Survey Results

Kudos to you! Oklahoma outranked the other 32 Campus Compact states in its response rate to the 2007 Campus Compact Annual Membership Survey with 94% of its member institutions responding. The 15-page survey results will be made available soon in detail. Until then, some of the highlights:

- Oklahoma still lags the average of Campus Compact states in the number of service-learning courses offered, the number of faculty teaching service-learning courses, and the percentage of students involved in community service, service-learning, and civic engagement activities;
- Oklahoma students average 4 hours per week participation in service activities compared to 5 hours per week average for Campus Compact states;
- Institutions in other Campus Compact states value the AmeriCorps*VISTA program more highly than do Oklahoma institutions; and
- Of resources and services offered, both Oklahoma and other states' institutions most highly valued the Compact-sponsored conferences and workshops, faculty development, networking opportunities, resource materials / support, and service-learning syllabi.

State Service-Learning Incentive Grants

Oklahoma Campus Compact will soon announce a third round of Service-Learning Incentive Grants, to be available for the Fall Semester, 2008 for first-time applicants. The grant consists of \$500 for expenses incurred in a service-learning course. Ten service-learning incentive grants were made in 2006-07, and another ten in 2008.

Student and Faculty Awards

Three student awards and one faculty award through the Oklahoma Campus Compact have application dates due March 21, 2008:

Swearer Student Humanitarian Award – Made by National Campus Compact, this award recognizes students for their innovative strategies to address community issues and needs, and their efforts to build and sustain this work among their peers and within their institutions. Five awards are made nationally; award consists of \$1,250 for student's use in professional development and \$250 donation to a service program/organization student has been involved with. Frank Newman Leadership Award – Made by National Campus Compact, this award is designed to support students with financial need who have shown civic leadership potential through public and community service and scholastic achievement. Two awards are made nationally; award consists of \$5,000 from the Frank Newman Leadership Fund. Apply at www.compact.org/awards/newman/2008.

Carter Academic-Service Entrepreneur (CASE) Grant – Made by the Jimmy and Rosalynn Carter Partnership Foundation for campus-community collaboration to three students in Oklahoma who indicate the most innovative and promising use of the \$1,000 grant to establish or significantly further a partnership between the student (and his or her school) and a community non-profit organization. Three awards for Oklahoma; award consists of \$1,000 for community need. Apply at: www.jrcpf.org and www.servicebook.org.

Thomas Ehrlich Faculty Award for Service-Learning - Campus Compact recognizes one faculty member each year for exemplary leadership in advancing the civic learning of students, including public scholarship, building campus commitment to service-learning and civic engagement, and fostering reciprocal community partnerships. The deadline for applications for this award is also March 21, 2008. One award of \$2,000 will be granted to a faculty member from a Campus Compact institution. Student Campaign for Public Service

A new initiative promoting service and civic engagement, the Student Campaign for Public Service (www.campaignforpublicservice.org) is looking for student leaders at Campus Compact schools. The Student Campaign for Public Service is a non-profit endeavor with support from the McCormick Tribune Foundation, the Rockefeller Brothers, and other leading national advocates for public service. It is also part of a larger organizing effort of proponents of expanding service programs and resources, Service Nation.

The student leaders will have the opportunity to work on a nationwide petition drive calling upon the presidential candidates to expand public service opportunities. The petition reads:

We, the undersigned students, care deeply about the many challenges that confront us today at home and abroad such as poverty, hunger, environmental crises, educational disparities, inequality and violence.

We believe that everyone should have the opportunity to participate in positive change through public service.

We call upon the 2008 presidential candidates to expand national service programs so that we, as a generation, can get to work.

In the months ahead, the organization aims to collect 50,000 to 100,000 signatures. Prior to the general election in November 2008, the students will publicly deliver their petitions to the presidential candidates.

Modeled after the 1960 University of Michigan student-led petition that inspired John F. Kennedy to create the Peace Corps, today's petition continues the rich tradition of campus activism and ongoing inspiration of the service-learning community and teachers.

Students who participate in this campaign will:

- Work with other students across the country
- Foster campus discussion about citizenship and public service
- Authentically engage in campus organizing methods
- Learn to make their voices heard
