## Voter Registration Contest Yields Almost 1,200 Voters

Congratulations to Oklahoma Christian University (OC) who won the 2007 Voter Registration Contest. The Oklahoma City-based campus registered 198 students during the five-day contest that took place on September 17-21. The total represents 11 percent of OC's entire student body. "Congratulations to Oklahoma Christian University for their great efforts in getting college students registered to vote and to all of the campuses that participated in this worthwhile effort," said Chancellor Glen D. Johnson. Chancellor Johnson will present OC with the 2007 Voter Registration Champion banner during a major campus event in January. Fourteen college campuses across the state registered 1,198 new student voters during the event. Eastern Oklahoma State College finished second by registering 118 students, and Connors State College placed third by registering 71 students. The winning campus is selected based on the percentage of students registered in comparison to total campus enrollment. This contest marked the fifth consecutive year that Oklahoma Campus Compact sponsored the Voter Registration Contest. Although the contest has concluded, campuses are encouraged to continue ongoing efforts by providing opportunities for voter education and by designating a location where students can register to vote. Students should be reminded and motivated to participate in the Oklahoma Presidential Preference Primary on February 5, 2008.

## Early Planning for 2008 King Day of Service

The 2007 King Day of Service was the largest and most successful ever, with hundreds of thousands of Americans serving in projects in all fifty states and had extensive media coverage. The Corporation for National and Community Service is urging every member of the national service family to participate – whether part of Senior Corps, AmeriCorps, VISTA, NCCC, or Learn and Serve America – whether a grantee, subgrantee, project sponsor, service site, member or volunteer.

The 2008 King Holiday will be January 21 and will be especially important as it comes 40 years after Dr. King's assassination. To help turn this attention into positive change for communities, The CNCS is joining with other organizations to honor Dr. King through "40 Days of Nonviolence: Building the Beloved Community." The King Day of Service will kickoff 40 days during which families, schools, faith communities, and other organizations will plan service projects and education activities promoting Dr. King's message of nonviolence and social justice.

## Civic Engagement

In the most extensive look at college students' attitudes on politics, civic engagement and voting in 15 years, the Center for Information and Research on Civic Learning & Engagement and The Charles F. Kettering Foundation have released a new study titled: Millennials Talk Politics: A Study of College Student Political Engagement. Available for downloading at <http://www.civicyouth.org>, the study made the following findings:

- Today's College Students are More Engaged than Generation X Was
- Millennials are Involved Locally with Others but are Ambivalent about Formal Politics
- Millennials Dislike Spin and Polarized Debates and Seek Authentic Opportunities for Discussing Public Issues
- Differences Among the Millennials: Colleges and Universities are Providing Very Unequal Levels of Opportunity for Civic Participation and Learning

This key report includes recommendations for more successful student engagement, and for future research areas.
