### Tackling Student Food Insecurity Wednesday, October 17, 2018 11:00 a.m. – 12:00 p.m. CST

According to research recently completed by Temple University and the Wisconsin HOPE Lab, 36% of college students today face food insecurity, 36% report facing housing security, and 9% report being homeless. These issues are significant barriers to student success. In this webinar, you will learn about a variety of ways in which higher education is tackling the issue of student food insecurity. We will then take a deep dive into Mount St. Joseph University's "Be Concerned Supplemental Nutrition Program", an innovative partnership with a local food pantry that provides supplemental food assistance to Mount students at no cost to the student or the University. The webinar will also provide an opportunity for participants to ask questions and brainstorm ideas on how to start food insecurity programs on other campuses.



## **Member Survey**

The results of the 2017 Campus Compact Annual Membership Survey of Service Statistics are posted on the OK Campus Compact Website. Please recall that the national survey was on hiatus last year, and at the request of its members, OKCC stepped into the gap to execute a survey for our state. Only 17 of the 36 OKCC members responded, for a response rate of 47%.

The national office has announced that the annual survey will be in hiatus again in 2019 as they continue to reassess and revise how to develop and utilize a tool that will advance our diverse civic and community engagement work. It will continue to seek member input and feedback as well as provide updates on developments—with a goal to launch a new survey instrument in 2020. Many members are dissatisfied with only quantitative data. Please remember that previous years' results are available on the national website at <a href="https://compact.org/?s=member+survey">https://compact.org/?s=member+survey</a>. This includes certain years by affinity. The OKCC Website has, for most years, the Oklahoma highlights compared to the national results, and the state-survey results for 2013 and 2017 <a href="https://compact.org/">HERE</a>.

In place of the national Member Survey in 2018 Campus Compact member campuses are invited to participate in a special collection of the NIIICE inventory. Campus Compact, in collaboration with the Swearer Center, the American Democracy Project, and NASPA – Student Affairs Administrators in Higher Education: NASPA LEAD Initiative are asking for your help in building a data set for a new revision of the NIIICE inventory. Why participate?

- 1. Contribute to knowledge in the field. Results from this special Collection of the NIIICE will be collected and published in a report from Campus Compact, ADP, and NASPA LEAD.
- 2. Understand the elements of engaged infrastructure. Simply by completing the inventory, you will have a better understanding of what it takes to support engaged work on your campus. For a small fee, you can receive a customized report that compares your inventory responses to the entire data set and to peer institutions. (Check back soon to see a sample report.)
- 3. Get ready to complete your Carnegie Classification or attend an Engaged Campus Institute.

What is the NIIICE? The NIIICE is a 120-question inventory of your campus' engaged infrastructure. The inventory asks questions about topics such as community based curriculum, organized infrastructure, budgets, etc. The NIIICE can be completed in two to three hours. Approximately 80% of the items can be completed either by an individual director or staff of a campus center or office coordinating community/civic engagement with little or no preparation or research. The remaining 20% will require obtaining data that can be retrieved from the institution's website and/or registrar's office. The inventory can be completed by a single, knowledgeable professional or by a team or staff as an exercise.

How much will it cost? An institution can participate in the NIIICE data collection project for free. The cost to receive an individualized campus report is \$150. If your campus has already participated in the NIIICE through an Engaged Instituted, the cost is \$50.

#### **Online Journal**





In this spring 2018 issue of North Carolina Campus Compact's peer-reviewed, online journal, hosted by the University of North Carolina at Greensboro, three articles addressing important social issues are featured. Stasinos Stavrianeas' pedagogical intervention demonstrates how college students can provide research designed to improve primary school nutrition. Chyrisse Heine examines how providing speech pathology interventions in Cambodia not only offered tangible benefit there, but also increased for students a global awareness of health disparities and policies. Jacquelyn Lee and co-authors document how applied learning pedagogy, including community engagement, was integrated into the ethos of the university in ways that target increasing social responsibility and an involved citizenry to benefit a myriad of social issues throughout the community. In addition, this issue includes an essay by Lisa Jakubowski and Martin McIntosh that reflects back on a controversial service-learning placement to illustrate how agency partners can be powerful activators for transformative experiences and outcomes. Finally, this edition offer reviews of three recent books relevant to scholars and practitioners of service-learning and civic engagement: 1) The Community Engagement Professional in Higher Education: A Competency Model for an Emerging Field; 2) Knowledge for Social Change: Bacon, Dewey, and the Revolutionary Transformation of Research Universities in the Twenty-First Century; and, 3) Language Beyond the Classroom: A Guide to Community-Based Learning for World Language Programs. # **Deepening Support for Community Colleges**



The Democracy Commitment, an effort dedicated to advancing the civic power of community colleges, has joined Campus Compact as a new initiative. This work will provide targeted programming and dedicated resources to support civic learning at community colleges. This webinar will feature examples of civic engagement from across the diversity of the community college realm.

# **Community Engagement Professional Credentialing Program**

Campus Compact is launching a credentialing program for Community Engagement Professionals (CEPs), designed to establish consensus on the skills and knowledge base CEPs need to promote effective community engagement and civic learning on their campuses, and to facilitate the emergence of a national learning community for CEPs and professional development. The <a href="Community Engagement Professional Credentialing Program">Community Engagement Professional Credentialing Program</a> will roll out a limited-enrollment pilot of the program later this fall that will focus on two micro-credentials: Community Engagement Fundamentals and Community Partnerships. This will be followed by a more extensive launch of the program in spring 2019. Campus Compact is working with its credential Content Advisory Board to finalize the protocol for inviting applicants and naming providers for the fall pilot.

# **Student Poverty Resources**

Caity Vogt, an AmeriCorps VISTA who served at the national Campus Compact office, worked to build capacity among member institutions to support students facing challenges related to housing insecurity and homelessness.

Caity developed a number of new resources for members including a Campus Compact Student Housing Insecurity Mapping Tool to assist campuses in assessing their ability to support students facing housing insecurity and homelessness. Another resource Caity developed is a Student Housing Insecurity Resource <a href="PAGE">PAGE</a> which contains a curated set of resources for member institutions to use when developing programming and building institutional procedures to assist students facing housing insecurity and homelessness. It contains a variety of program models, interventions, and pieces of research that individuals on campuses can use to inform and direct their own action plans to meet the needs of their students.

# Campus Compact Education for Democracy Initiative

Campus Compact and panOpen, a learning platform that supports institutional use of Open Educational Resources (OER), have announced a partnership to launch **Democracy Learning Channel (DLC), an area within the panOpen platform dedicated to providing college** 

**instructors with openly accessible tools and guidance to advance student learning about democracy**. Materials provided through DLC will be organized around particular themes, ultimately creating a cross-disciplinary range of curated OER courses and individual modules focused on student civic learning. Courses and modules will include materials such as original and interpretive documents, prompts for projects and writing assignments, and guides for experiential learning activities. All materials will be available under Creative Commons licenses and will be free to use, share, and adapt for the classroom.

The open character of the initiative is intended to foster collaboration and dialog among scholars, researchers, civic organizations, instructors, and students. While the initial content will be released by a founding group of content partners, instructors will be able to modify the materials to meet their own teaching needs and interests. Modified course materials can then be shared through DLC so that other instructors can make use of these alternatives.

"In bringing together Open Educational Resources and democratic learning, Campus Compact and panOpen are recognizing that enabling all students to have access to the learning necessary for full participation in our democracy is a crucial equity issue," said Karen Stout, president and CEO of Achieving the Dream, Inc., and president emerita of Montgomery County Community College. "Democracy Learning Channel is a forward-looking initiative that will serve all of higher education and will have special significance to students at community colleges--nearly half of all students in the United States."

The first OER course to be made available through DLC, "Democracy in Troubled Times," will be released this fall. Curated by Campus Compact and panOpen, course modules will include activities and resources centered around the evolution of democratic ideas, the spread of democratic beliefs, and the characteristics of democracy during periods of stress and crisis. Students will be encouraged to explore the past through deliberative forum and debate, immersive activities, and examination of key documents. Themes will include historical inquiry into the conflicts at the origin of our democratic institutions, and strategies to foster critical thinking regarding claims presented in the media, whether through major news outlets or social media.

This work is a component of **Education for Democracy**, Campus Compact's non-partisan initiative that aims to help heal and reinvigorate democracy by engaging students in courses, programs, and activities designed to develop the knowledge, skills, and motivations essential for responsible and effective participation in democracy.

#### **Call for Submissions**

The <u>Journal of Community Engagement and Higher Education</u> and <u>Indiana Campus Compact</u> are partnering for a special edition dedicated to **Critical Service-Learning**. Critical service-learning is an approach to community engagement that prioritizes attention to social change by interrogating systems and structures of inequality, questioning the distribution of power, and seeking to develop authentic relationships among students, faculty, community partners and members (Mitchell, 2008).

This issue will be guest edited by Dr. Tania D. Mitchell. Scholars and practitioners of critical service-learning and social justice are invited to submit manuscripts no later than **November 30, 2018**. The full call for submissions can be accessed at

This special issue intends to highlight research that explores critical service-learning experiences or the relationship between service-learning and social justice. Case studies that emphasize critical service-learning experiences, detail efforts to employ a critical service-learning framework, or offer constructive critique that may move a community engagement project towards a more critical or social justice focused practice would also be welcomed. Scholarly pieces reflecting on critical community engaged practices, challenging higher education and/or the service-learning/community engagement field, and outlining progressive models for community engaged work will also be considered.

In your abstract, please include the following information:


- Research purpose or question(s)
